Requirements For Hazardous Waste Landfill

Modern landfills are well-engineered facilities designed to receive specific kinds of waste, including municipal solid waste (MSW), construction and demolition debris (C&D) and hazardous waste. Landfill facilities must be designed to protect the environment from contaminants, which may be present in the solid waste disposed in the unit.

All hazardous waste landfills are required to have a run-on control system, a runoff management system, and control the wind dispersal of particulate matter. The run-on control

system must have the capacity to prevent flow onto the active portion of the landfill during peak discharge of a 25-yr storm and the runoff management system must have an adequate capacity to collect and control water from a 24-h, 25-yr storm and the contents tested to determine correct disposal methodology.

The exceptions to this requirement are small landfills that receive less than 20 tons of solid waste per day, and facilities that can demonstrate that there is no potential for the migration of hazardous constituents from the unit into the groundwater.

EPA's minimum technological requirements for hazardous waste landfill design and construction were introduced by Congress in the 1984 Hazardous and Solid Waste

Amendments (HSWA). In HSWA Section 3004(0)(1)(A), Congress required all new landfills and surface impoundments to have double liners and leachate collection and removal systems (LCRS).

A grant of authorization from the Department is required for a Hazardous Waste Storage Facility. Tank: A stationary device, designed to contain an accumulation of hazardous waste constructed primarily of non-earthen materials (e.g., wood, concrete, steel, plastic) which provide structural support.
